By signing this statement, I certify that all are true and accurate as they relate to this entry.

1. The contents of this entry are the results of my work or, in the case of a team project, the work of current members of this team.
2. Credit for all secondary research has been given to the original author through the project's bibliography, footnotes or endnotes.
3. All activities or original research procedures described in this entry are accurate depictions of my efforts or, in the case of team projects, the efforts of my team.
4. I understand that Foundation⁴Innovation has the right to publish all or part of this entry. Should Foundation⁴Innovation elect to publish the entire entry, I will receive an award or an honorarium from Foundation⁴Innovation.

Individuals with extenuating circumstances may appeal the right to publish the entry to the executive committee of the board of directors prior to April 15. This statement of assurances must be signed by all participants and the chapter advisor, and submitted with the entry, or the entry may not compete.

Media Release:



The rights granted Producer herein are perpetual and worldwide.
